Report by the Networker

This has been a busy year for the Network, with the launch of *Open to All?* and increased interest in its work. As Networker, I have worked some 580 hours since April – this is an outline of what that involved.

Based partly on the feedback from the Seminars and from members, partly on the importance

of disseminating the findings from the research report, *Open to All?*, and partly on the need to raise the Network's public profile, I have spent a major part of my time this year developing the Network's own programme of training courses and contributions to other courses.

The Network's programme started with the Briefing in August, and runs through until March. I have developed the programme in conjunction with some of the colleagues listed above, and designed and delivered some sessions (eg the "Clause 28" Briefing; "Managing Public Libraries for Social Exclusion"), facilitated some (eg "Library Services for Refugees and Asylum-seekers"), and carried out the administration for the whole series. I also organised and administered the London Seminar and Conference, and spoke on the Manchester Seminar.

I have also run or contributed to a number of courses for member authorities, including those for Enfield, Gloucestershire, Lambeth, SHARE and Wandsworth; and have spoken at 4 other training events (PTEG "An evening with ..."; the Conference to launch *Open to All?*; the YLG Day School; City and Islington College training day; the EARL course on children and social exclusion).

I have contributed articles and reviews to *The Library Association South Western News*; *LASERLink*; *Public Library Journal*; *Personnel, Training and Education*; *Impact*; *Information for Social Change*; wrote the responses to the documents listed above; and collected most of the content for and wrote the 8 issues of the Newsletter since April 2000.

I have met many of you over the year at courses and other events; I have also had specific meetings with Jonathan Douglas and Penny Simmonds (Library Association), Fiona O'Brien (BBC Education), Liz Dubber (ASCEL), Caroline Lang (Resource), Neil McClelland and Genevieve Clark (National Literacy Trust), Miranda McKearney (Well Worth Reading), David Murray (LLDA), Anne Harding (Anne Harding Training), Chris Meade and Suzy Behr (Book Trust); Robin Yeates (LASER), and Fiona Hutchison (Website designer).

I also attended the Saturday session of "Under the Covers" (the School Libraries Group/Youth Libraries Group/School Library Association joint conference); the first of the EARL social exclusion courses ("Connecting the people in your neighbourhood: social inclusion, community partnerships, and public library networking"); and the EARL AGM.

In addition, I have carried out all the administration for the Network, including invoicing and banking income; dealing with suppliers' invoices and raising cheques; and answering the growing volume of letters about the Network's work.

This has been a busy and satisfying year (as many of you will know, I also worked, firstly fulltime and latterly part-time, for Enfield Libraries for just over 5 months), and I look forward to the continuing development of the Network in 2001/2.
