Destitution in the UK 2018

Key findings include:

- "1,550,000 people, including 365,000 children, experienced destitution in the UK over the course of 2017.
- Destitution typically happens when people have been trapped in sustained poverty and long-term hardship.
- People are generally pushed from severe poverty into absolute destitution by a combination of factors: debt, benefit and health problems. Extremely low levels of benefits, especially for younger people, or no eligibility for benefits, for some migrants, also drive people into destitution.
- Single men under 35 years old are at highest risk of destitution. Threequarters of those in destitution were born in the UK.
- Almost all people experiencing destitution live in rented, temporary or shared accommodation. Homeowners and older people rarely experience destitution. The lack of low-cost rented housing and gaps between rent and housing benefit levels push people over the brink.
- Destitution is clustered in major northern cities and some London Boroughs. Rates are low in the prosperous parts of southern England.
- Levels of destitution have declined by around 25% between 2015 and 2017, and benefit sanctions changes appear to be the most significant factor behind this.
- The high sanction rate within the Universal Credit system could lead to an increase in levels of destitution in the future." [Summary, p3]

"This latest allocation from the Controlling Migration Fund includes more than £16 million for 38 projects. Local authorities have developed plans to ease local pressures on housing, education and health services arising from recent migration providing benefits to the whole community.

The announcement today includes £1.75 million of funding to help new refugees into work and integrate into their new communities after their asylum decision is made. It also includes £1.1 million for 6 councils to support victims of modern slavery to link up with local services when they leave central government-funded support, thereby reducing their risk of becoming homeless, sleeping rough, or being re-trafficked."

"Non-UK born and non-British populations continued to increase in 2017, as more people continue to come to the UK to live than move to live abroad for a year or more.

"Poland-born residents and Polish nationals were the most common populations from outside the UK, with an estimated 1 million Polish nationals now living in the UK. However, the largest increases in population were seen from those born in Romania and those with Romanian nationality."

- 115 events such as 3D printing, how to pitch, and crowdfunding, as well as inspiring talks"

As an indicator of its success:

- "84% of participants felt their skills had increased
- 96% of participants have increased their knowledge
- 70% of participants have increased their self-confidence
- 59% of participants have increased their self-esteem
- 99% would recommend the event/session to family and friends"
